**Stallion Service Agreement (Live Cover)**

**BREEDING FEES:**

- Stud fee: **\$800.00**
- **\$200.00** non-refundable booking fee, as part of the stud fee, submitted with contract.
- Stud fee **must** be PAID IN FULL prior to breeding

**UNDER THE FOLLOWING CONDITIONS:**

- Mare Care - **\$12.00/day/dry** and **\$15.00/day/wet (Multi mare discount if dropped off at the same time)**
- Stud fee balance is to be received **at time** mare is dropped off for breeding
- A mare will not be removed from **ESH** property unless fees/expenses are paid in full
- **ESH** agrees to provide proper care of mare while in its care
- Mare owner is responsible for any veterinarian care/fees required
- If mare owner's veterinarian is unavailable, **ESH's** veterinarian will be contacted
- Mare care **DOUBLES** after the requested mare pick up date
- All outstanding fees (i.e. veterinarian, mare care, etc.) must be paid before mare leaves

**Right of Refusal:** **ESH** reserves the right to refuse service to any mare or cancel this agreement without notice and without recourse to mare owner if said mare habitually aborts and/or has been bred any two consecutive years without producing a live foal.

**Mare's Post-Breeding Examination:** The mare owner will ensure that the mare is examined by a veterinarian between **14 and 40 days** after insemination. If the mare is not in foal at this examination, **ESH** must be contacted to arrange re-breeding for the next estrus cycle. If it is late in the year, arrangements will be made to re-breed the following year.

**Care of Mare:** Mare owner will ensure that the mare is properly cared for and will receive all necessary deworming, vaccinations and veterinary care during pregnancy. Failure to comply will void the Live Foal Guarantee.

**Stallion Service Agreement (Live Cover)**

**Service Certificates:** ESH will complete all necessary paperwork required on the stallion owner’s part to facilitate registration of foal.

**Live Foal Guarantee:** Should the mare fail to conceive, die, or not produce a live foal, the mare owner shall have the option of re-breeding this mare or a substitute mare (upon approval of **ESH**) during the next breeding season. An additional booking fee will be charged for a substitute mare. A live foal is defined as a foal which stands and nurses without assistance for 48 hours after birth. A veterinarian’s statement confirming loss of the foal is required.

**Change in Fitness to Breed:** In the event the above-named stallion dies or becomes unfit for service before breeding season end, this contract shall become null and void and the stud fee will be returned. In the event the above-named stallion dies or becomes unfit for service after breeding and the mare is confirmed not in foal, this contract shall become null and void and the stud fee will be returned.

**Agreement of Parties:** This agreement represents the entire agreement between the parties. No other agreement or promises verbal or implied are included unless specifically stated. This contract is made and entered into in the Province of Alberta and will be interpreted under the laws of this Province.

**Signatures:** This contract has been executed in duplicate and when signed by both parties will be a binding contract on both parties, subject to the above terms and conditions.
